**RANGE/TRAINING SAFETY BRIEFING AND RANGE**  
**RULES**

**BASIC FIREARMS SAFETY RULES:**

- 1) TREAT ALL FIREARMS AS IF THEY ARE LOADED;
- 2) DON'T POINT FIREARMS AT ANYTHING YOU DO NOT WISH TO DESTROY;
- 3) KEEP YOUR FINGER OUT OF THE TRIGGER GUARD UNTIL YOU'RE READY TO SHOOT;
- 4) BE SURE OF YOUR FOREGROUND, TARGET AND BEYOND.

**RDI SITE SPECIFIC RULES:**

- 1) TRAIN WITH RESPECT;
- 2) ANYONE CAN CALL A "CEASE FIRE" or "BREAK" IN CASE OF AN EMERGENCY;
- 3) YOU ARE RESPONSIBLE FOR YOUR WEAPON SYSTEM AND TRAINING EQUIPMENT;
- 4) EVERYONE MUST HAVE "EYES AND EARS" ON "HOT RANGE";
- 5) PICK UP YOUR TRASH, POLICE YOUR BRASS, AND RESET ANY STEEL TARGETS USED;
- 6) SHOOTING WILL ONLY OCCUR BETWEEN THE YELLOW LATERAL LIMITS UNLESS PRIOR APPROVAL HAS BEEN GIVEN;
- 7) SHOOTING WILL NOT OCCUR PAST THE 25 YARD LINE;
- 8) ABSOLUTELY NO FIRING AT ANGLES HIGHER THAN THE LATERAL LIMITS;
- 9) ABSOLUTELY NO WEAPON MANIPULATION AT THE SERVICE TABLES;

**10) ALL PARTICIPANTS MUST SIGN IN AND SHARE EMERGENCY CONTACT INFORMATION AND ADVISE INSTRUCTOR OF ALLERGIES TO MEDS.**
